# **IMPORTANT PRE-COLLECTION INFORMATION**

Please note that this test relies on using live blood cells for performing the analysis. Ensuring that these collection instructions are <u>followed accurately</u> <u>will ensure</u> that you receive accurate and meaningful results.

Prior to having the sample collected you need to avoid the following:

| MEDICATION             | WITHHOLDING PERIOD  |

| Antihistamines         | 3-5 days prior to sample collection.                            |
| Oral Steroids          | 4 weeks (consult with your healthcare practitioner beforehand)  |
| Steroidal nasal sprays | 48 hours prior to sample collection.                            |
| Vitamin C (High Dose)  | Reduce to 500mg/day at least 3 days prior to sample collection. |
| Antibiotics            | Wait for acute symptoms to abate.                               |

Other medications should be withheld until after the blood collection. If suffering from viral infections (EBV, CMV, etc), please wait until you have fully recovered before having the blood collected.

# **BLOOD SPECIMEN COLLECTION AND PATIENT INSTRUCTIONS**

- Please phone the lab at your nearest location to arrange an appointment time (except Christchurch where no appointment is necessary).
   Please let the lab know that this is an ALCAT test from Nutrisearch.
- There is a blood collection fee that is payable at the time of blood collection. Please enquire directly with lab for for the correct amount.
- Complete all sections of the patient and practitioner details section on the test request form provided.
- Leave the kit and paperwork with the Lab. They will liaise with Nutrisearch to have your sample sent to Nutripath for testing.

# PATHOLOGY COLLECTION INSTRUCTIONS STEPS 1-3:



The pathology collector should collect ALL of the provided tubes within the NutriPATH kit.

The blood MUST be collected using the glass citrate tubes provided inside this collection kit.

The test requires 3 tubes of 4.5ml draw OR

4 x tubes of 4.5ml draw for PLATINUM profile Paediatric Profile only requires 1 x tube of 4.5ml

- 2. Prior to sample collection, all sample vacutainers must be labelled with the patient first name/surname, date of birth and time and date of collection.
- **3.** After sample collection, all samples should be gently inverted 5-7 times to ensure the blood has been well mixed with the additive inside the vacutainer blood tubes.

## PACKAGING INSTRUCTIONS STEPS 4-8:

- 4. Wrap the blood samples in the cotton wool provided and place it in the inner plastic transport cylinder for transport protection. DO NOT put cold packs or ice packs near blood samples. This will destroy the blood cells and render samples useless for testing. The specimens should be transported at room temperature.
- 5. Ensure the patient has ticked the correct ALCAT analysis.
- 6. Place the test request form into the inner plastic transport cylinder.
- 7. Place the inner transport cylinder into the outer cardboard cylinder. Cap the outer transport cylinder with the red plastic lid.
- **8.** Please liaise with Nutrisearch immediately to organise transit of specimen to Nutripath in Melbourne, Australia.
